416. **Sardar Amarjit Singh Sandoa, M.L.A.:-** Will the Health and Family Welfare Minister be pleased to state the total amount released for taking care of individuals quarantined in district Roopnagar due to Covid-19 so far alongwith the details of expenditure of the supra amount?

**The Repair of Roads Dugout for Laying Pipes of Saskaur Water Project**
