**Sanctioned posts of Govt. Schools in Assembly Constituency Garhshankar**

- \*292. **Sardar Jai Krishan Singh Rouri, M.L.A.**:- Will the Education Minister be pleased to state the number of Government Elementary, High and Senior Secondary Schools in Assembly Constituency Garhshankar and the number of sanctioned posts therein alongwith the number of vacant posts out of the same togetherwith the time by which vacant posts are likely to be filled up?

**To Set-up Industry at Village Madnipur Tehsil Payal**
