To Implement the Reservation Policy for SC/BC in Government Aided Schools

- Doctor Sukhwinder Kumar, M.L.A.:- Will the Education Minister be pleased to state that:-87.
- whether the reservation policy for Scheduled Castes and Backward Classes is being implemented in letter and (a) Spirit for the staff recruited in Government Aided Schools at the time of the recruitment and promotion in services and vacancies of the State;
- if the reply to part (a) be in affirmative, the number of teaching and non-teaching employees recruited in the (b) Aided Schools of the State from January, 2007 to date togetherwith the number of employees belong to Scheduled Castes and Backward Classes out of them; if not, the time by which the due representation will be given to Scheduled Castes and Backward Classes in recruitment as per the reservation policy togetherwith the action taken by the Government against the officers who disregard the constitutional reservation policy, the details be given?
